CLASS A DISTRIBUTION WAREHOUSE

Meridian at Weston is a Class A Cross Dock $\pm 232,000$ SF industrial manufacturing/distribution building situated on ± 11.17 acres of land.

The property is conveniently located less than one mile from I-75 between Griffin Road and Royal Palm Boulevard exits in Weston, FL. The property features tilt-wall construction, steel rebar roof support systems with single-ply membrane roof and Class IV fire suppression system. Electric service consists of ±2,200 Amps/ 480 Volt and is 3 phase. The building has guard gate access to the loading area and 45 trailer drops.

The property contains additional land that is utilized for additional parking and/or trailer storage.
